**PRODUCT INFORMATION:** Morral 9% Zinc is a fully chelated solution of zinc EDTA and is recommended for the prevention and correction of zinc deficiency in all crops. Morral 9% Zinc is recommended for use on all soil types. The preferred use is soil application to prevent the deficiency although it may also be used as a foliar spray for correction.

**DIRECTIONS FOR USE:** Morral 9% Zinc may be applied in water or liquid fertilizers and suspensions, with most pesticides. Application rates and dilution factors depend on crop sensitivity, the amount of foliage to be sprayed and the application method. See chart below for suggested application rates for one growing season (per acre) in the absence of a soil test.

Field & Row Crops:	Foliar	1-2 pints
