**PRODUCT INFORMATION:** Morral Wheat Mix may be used with ortho and poly phosphate products. Using Morral Wheat Mix in the pop-up products, growers can provide micronutrients in a form that will assure availability to young plants. Morral Wheat Mix may be corrosive to aluminum, mild steel and brass. Store in HDPE, fiberglass or stainless steel containers. Use only stainless steel, PVC, or polypropylene fittings.

**DIRECTIONS FOR USE:** Morral Wheat Mix is recom-mended for use on all soils. For best results incorporate in fertilizer or mix in water. This will aid in uniform distribution. See chart below for suggested application rates for one growing season (per acre) in the absence of a soil test.
